Country Guide: Bangladesh

Used Household Goods and Personal Effects

Documents Required

- 1. Passport
- 2. Original bill of lading (OBL) / express release / air waybill (AWB)
- 3. Customs passbook issued by the National Board of Revenue (NBR)
- 4. Packing list / detailed inventory
- 5. Baggage declaration form, completed upon arrival and signed by Customs
- 6. Inspection order form (IOF) / inspection information form (IIF)
- 7. Pro-forma invoice
- 8. Transfer of residence certificate (returning Bangladeshi)
- 9. Letter of employment (foreigners)
- 10. Work permit (foreigners)
- 11. Tax exemption certificate from the Ministry of Foreign Affairs (diplomats)

Specific Information

- 1. Bangladeshi citizens and foreigners may import used household goods and personal effects into Bangladesh.
- 2. Duty-free importation is allowed for embassy, high commission, United Nations, international donor agencies and their employees.
- 3. Foreigners, NGO employees and foreign investors must pay duties and taxes for household goods and personal effects.
- 4. Bangladeshi citizens can import personal and household goods at a tax benefit of up to 80% on the assessable value.
 - Citizens must stay abroad with no re-entry for 2 years to qualify for the tax benefit.
 - The first 2 years receive a 40% benefit and 10% each subsequent year.
 - Citizens must obtain a certificate from the embassy / high commission stating the period abroad.
- 5. Bangladeshi citizens, foreigners, NGO staff members and foreign investors must complete a baggage declaration form within 20 days of arrival.
- 6. Diplomatic personnel may obtain permission to import items duty-free from the diplomatic organization.
- 7. Privileged persons (diplomats, employees of a UN agency, some NGO employees, or employees of a foreign company having a contract with the Bangladesh government identifying them as such) must obtain a Customs passbook from the owner of the goods' employer, who must apply for the passbook upon the owner of the goods' arrival.
- 8. The Customs passbook is required for the duty-free entry and takes approximately 25-30 days to obtain.
- 9. The owner of the goods must be present for Customs clearance with the original passport and OBL / express release.
- 10. It takes approximately 5 business days to clear full container load (FCL) shipments and approximately 3 business days for air shipments.
- 11. It is advised that FCL shipments arrive in the Dhaka Dry Port (ICD is recommended for FCL shipments with port of entry (POE) at Chittagong).
- 12. All less-than-container loads (LCL) are recommended through POE Chittagong.

Motor Vehicles

Documents Required

- 1. Purchase invoice
- 2. OBL

Specific Information

- 1. Vehicles 3 years and older cannot be imported.
- 2. Vehicles are subject to duties and storage charges.

Pets

Documents Required

- 1. Vaccination record
- 2. Veterinary health certificate
- 3. Letter of no objection (letter of permission from the Bangladesh government)

Specific Information

- 1. The veterinary health certificate must be issued within 7 days of import and must state that animal is free from rabies and other infectious diseases.
- 2. Cats, dogs, birds and many other types of pets can be brought into Bangladesh without a quarantine period.

Restricted/Dutiable Items

- 1. Firearms and ammunitions (permission is required from the Ministry of Home for dealers and the Ministry of Commerce for private citizens)
- 2. Vehicle parts (contact agent for specific information)
- 3. Agar and pectin (permission from the Director of the Drugs Administration is required)
- 4. Meat and bone meal
 - Radioactivity-test reports from the origin country and a certificate stating the products are fit for consumption from fish, poultry or other animals is required.
 - The radioactivity-test report must clearly indicate the level of CS-137 found in each kg of each item.
- 5. The following items may be imported duty free within the limits indicated:
 - Cigarettes (200), cigars (50), tobacco (225 g)
 - Alcohol (2 bottles)

Prohibited Items

- 1. Firearms and ammunition
- 2. Pornographic materials
- 3. Polypropylene bags
- 4. Gambling instruments
- 5. Narcotics
- 6. Maps and charts (contact agent for specific information)
- 7. Poppy seeds and opium
- 8. Frogs and frog parts
- 9. Food grains
- 10. Subversive literature
